I can confirm, as far as can reasonably be ascertained by careful external examination, that the body of the deceased does not contain a pacemaker, implanted cardioverter defibrillator (ICD), Implanted pulse generator or similar device or Intramedullary Fixon Nailing or Baclofen Pump (intrathecal system of delivering medicines).
